## CONDITIONS OF PROBATION

The defendant is placed on probation. The following are general conditions of probation by the Court pursuant to Chapter 2951 of the ORC, and shall apply to all persons placed on probation by this Court and shall be requirements and conditions from the date hereof, namely:

- \_\_\_\_\_(1) Probationer shall not violate any Federal, State or Local laws.
- \_\_\_\_\_(2) Probationer shall comply with all orders set forth by the Court and their individualized case plan.
- \_\_\_\_\_(3) Probationer shall work regularly at a lawful occupation and support their legal dependents to the best of their ability. When the Probationer is out of work they shall notify the Court immediately.
- \_\_\_\_\_(4) **Probationer shall not possess or have under his/her control any firearms at any time. Nor shall the Probationer have under their control or possession any deadly or dangerous ordnance as defined in Section 2923.11 of the Ohio Revised Code.**
- \_\_\_\_\_(5) Probationer shall not patronize any business or establishment where alcoholic beverages are sold for consumption on the premises.
- \_\_\_\_\_(6) Probationer understands the Probation Officer has a right to search (**see page two for ORC definition**).
- \_\_\_\_\_(7) Probationer shall not possess, use, sell, distribute or have under their control any narcotic, barbiturates, and or controlled substances set forth by Sections 3719.10, 3719.23, 3719.41 of the Ohio Revised Code, or extracts containing prescription of a licensed physician. Probationer shall not at any time to be found in the state of intoxication or under the influence of illegal drugs, drugs that are not legal in Ohio or prescribed to them. Probation must take all medications as prescribed. Probationer will submit to random drug testing and or alcohol testing as a condition of your supervision as requested by the Probation Department or any other law enforcement agency while in said program. Probationer is subject to routine or random checks as needed anywhere the Probationer may be (home, work, school etc.). All medications need to be provided and approved by the Probation Department (Example: Kratom).  
If prescribed Marijuana, the Probationer must provide the probation staff with proof in the form of your Medical Marijuana Registry Card.
- \_\_\_\_\_(8) Probationer shall make regular payments as set forth by the Court on all restitution, fines, Court costs and Supervision fee of \$100.00. The Supervision fee will be charged one time per sentencing and will be amortized over the one or two year probation period.
- \_\_\_\_\_(9) Probationer shall report to the Sidney Municipal Court Probation as ordered. If no date and time are designated, it is the responsibility of each individual Probationer to contact the Court in regards to reporting in. If a Probationer misses a scheduled appointment a probation violation/sanction may be issued.
- \_\_\_\_\_(10) Appropriate attire is required while visiting the Probation Department. Shoes and shirts must be worn at all times.
- \_\_\_\_\_(11) Probationers placed on the Electronic Monitoring System will be responsible for the daily cost of the program. Payments shall be made one week in advance.
- \_\_\_\_\_(12) No violence of any kind will be tolerated at any time.
- \_\_\_\_\_(13) Respect will be shown at all times to the staff of the Court and other Probationers that may be present. Staff members will be addressed by their proper name. No nicknames of any kind will be tolerated.
- \_\_\_\_\_(14) All payments will be applied to the oldest case first and then paid in chronological order. **NO EXCEPTIONS.**
- \_\_\_\_\_(15) Probationer shall acknowledge and agree to the implementation of graduated sanctions as outlined in separate notification (Sanction/Response Grid) and agreement, including possible jail time in the event of non-compliance with the terms of probation.
- \_\_\_\_\_(16) Probationer shall keep the Court advised of their current address, phone number, and employment changes. Any change must be reported immediately.
- \_\_\_\_\_(17) Probationer shall sign a release so their Officer can communicate with other agencies in reference to their progress and/or background.
- \_\_\_\_\_(18) Probationer shall notify their supervising officer within 24 hours if they have had contact with law enforcement for any reason.

Condition #6 ORC definition

## § 2951.02. Authorized searches during offender's misdemeanor community control sanction or felony nonresidential sanction; community service; ignition interlock devices.

(A) During the period of a misdemeanor offender's community control sanction or during the period of a felony offender's nonresidential sanction, authorized probation officers who are engaged within the scope of their supervisory duties or responsibilities may search, with or without a warrant, the person of the offender, the place of residence of the offender, and a motor vehicle, another item of tangible or intangible personal property, or other real property in which the offender has a right, title, or interest or for which the offender has the express or implied permission of a person with a right, title, or interest to use, occupy, or possess if the probation officers have reasonable grounds to believe that the offender is not abiding by the law or otherwise is not complying with the conditions of the misdemeanor offender's community control sanction or the conditions of the felony offender's nonresidential sanction.
