Two 5/8" X 3/4" taps.....	\$3,994
One 1" Tap with two 5/8" X 3/4" Meters.....	\$4,233

Sewer Taps for Doubles & Duplexes:

\$125 for the 1st unit plus \$75 for each additional unit.

Reimbersements: Front footage charges where applicable.

Street repairs are in adition to tap fees at Time & Material Costs.

Plant Investment Fee (P.I.F.):

Set by Chapter 913, Section 911.04 of the Codified Ordinances.

Sewer District Assessment (SDA):

Set by Chapter 913, Section 913.11 of the Codified Ordinances and are effective forever.

West SDA	bounded on the east by I-75, on the south by a line extending 1600 feet south of and parallel to Millcreek & Fair Roads and bounded by the west by a line extending 1000 feet west and parallel to Kuther Road and bounded by the north by a line extending 3200 feet north and parallel to State Route 47.
